Further, I certify individually and on behalf of said applicant Entity: 1. That said applicant Entity is legally formed pursuant to applicable state law and shall comply with all Oklahoma laws necessary to validly operate within the State of Oklahoma; 2. That said applicant Entity will comply with federal and state laws applicable to appraisal management companies, the Oklahoma Appraisal Management Company Regulation Act and the administrative rules promulgated by the Oklahoma Real Estate Appraiser Board in all its conduct under any certificate of registration issued pursuant to this application; 3. That no person owning more than ten percent (10%) of the applicant Entity has held or applied for a credential to act as a real estate appraiser in any appraiser-credentialing jurisdiction, which credential was refused, denied, cancelled, revoked or surrendered in lieu of discipline and was not subsequently granted or reinstated; 4. That no entity that owns more than ten percent (10%) of the applicant Entity is more than ten percent (10%) owned by an individual who has held or applied for a credential to act as a real estate appraiser in any appraiser-credentialing jurisdiction, which credential was refused, denied, cancelled, revoked or surrendered in lieu of discipline and was not subsequently granted or reinstated: 5. That the applicant Entity has a system in place to verify that a person being added to the appraiser panel of the applicant Entity for appraisal services being performed in Oklahoma has a credential in good standing in this state pursuant to the Oklahoma Certified Real Estate Appraisers Act and the rules promulgated thereunder if such a credential is required to perform appraisals pursuant to 59 O.S. § 858-812; 6. That the applicant Entity has a system in place to review the work of a statistically significant number of appraisal reports submitted by each appraiser who is performing real estate appraisal services in Oklahoma for the Entity on a periodic basis to validate that such services are being performed in accordance with USPAP and the Oklahoma Certified Real Estate Appraisers Act pursuant to 59 O.S. § 858-816; 7. That the applicant Entity maintains a detailed record of each service request that it receives for appraisal; services in Oklahoma and the appraiser that performs real estate appraisal services for the Entity pursuant to 59 O.S. § 858-817 (A); and 8. That an intentional misstatement of any fact required to be disclosed on this application constitutes a violation of the Oklahoma Appraisal Management Company Regulation Act and shall be cause for refusal or revocation of a certificate of registration. I understand and agree that the Oklahoma Real Estate Appraiser Board may conduct any background investigation it deems necessary, including but not limited to verification of any and all information provided herein.
